

# **Annual Risk Management Summary for Avon Tyrrell Outdoor Centre**

The following risk management summary has been produced to support visitors to Avon Tyrrell Outdoor Centre. A centre operated by the charity UK Youth. This risk summary aims to demonstrate how our risk analysis and management schemes are adequately robust for our visitors regardless of the purpose of their visit.

We recommend group leaders, when organising their visit, carry out a pre-visit if practicable, to support their own risk assessments and have an opportunity to address any points with our staff team. Group leaders must contact our Customer Experience Team at least one week before arrival, to confirm that no significant site changes have occurred that may affect a groups Risk Assessment.

# Safeguarding – The protection of children, young people and adults at risk

All Avon Tyrrell based staff hold an Enhanced Disclosure Barring Service (DBS) check, and our safeguarding <u>policy</u> is consistent with current good practice, statutory requirements and staff receive annual training.

### **Supervision**

- Whilst on site, group leaders have overall responsibility of their group, and we strongly recommend a minimum ratio of 1:10 leader to participants for young people.
- During guided activity sessions, Avon Tyrrell staff ensure participant safety.
  - o For organised groups At least one group leader must be present during every session for pastoral/behavioural supervision (unless by prior agreement). This is recommended to be on a ratio of 1:10 leader to participants.
  - o For individuals Young people under 8 years must have a supervising adult with them at all times. Those 8-15 years can be left to participate independently in activity sessions; however, our <u>unaccompanied child and young person policy</u> must be followed.
- Reception is open during the day for assistance and designated staff are On-Call outside reception hours and overnight for emergencies.

### **Staff Competence and Qualifications**

Staff are recruited with a suitable level of role specific competency (qualifications and experience) and on-going staff training and quality assurance are an essential part of our operation. Competence may be defined by; a nationally recognised qualification, an assessment by an independent technical expert, or internal training and assessment appropriate to the technicality of the activity to which they relate. Copies of qualifications and training records are available on request.



#### **Risk Assessments**

In addition, our operating procedures and risk assessments are reviewed annually or sooner if legal changes occur or we change an operating process.

# **Equipment**

All site equipment will be fit for purpose and is inspected by competent staff and by external specialists or advisors. We maintain digital records of equipment checks, which support our quality assurance processes.

# **Transport**

We do not provide transport for our visitors. All vehicles used to conduct the operational activities of the Centre are insured, regularly inspected and hold valid documentation. To control traffic movement across our site we have a number of traffic calming measures in place including speed cushions, pinch points and signage clearly indicating our onsite speed limit.

### **Fire Protection**

- We adhere to Fire Precautions (Workplace) Regulations 1997 and the Fire Safety Reform Order (2005), whereby we assess our entire site for fire risks. We have regular visits and discussions as appropriate by Hampshire Fire and Rescue Service and our local Fire Station and act on their recommendations as required.
- Fire drills are carried out for groups staying in the main house where the group are predominantly under 16 years and all groups are given a welcome safety talk or site information documents. All our accommodation units are annually inspected and serviced by our contractors, Wessex Fire and Security.
- To support our fire protection management our main house has automatic sensors and is linked directly to a fire alarm monitoring service, and we have a fire sprinkler system installed in our roof spaces.



# **Security Arrangements**

Our security arrangements on site include;

- Staff available 24hours a day via reception or our On-Call arrangements.
- Welcome talks and/or information packs which include emergency contact points.
- CCTV in selected locations.
- Lockable accommodation, our main house and lodges have programmable coded door entry.
- Security barrier at our main entrance for enhanced security of the site.
- Regular staff training on all aspects of Health and Safety and security, child protection/safeguarding.
- Regular liaison with emergency services.
- Maps demarcate out of bounds areas and identified hazards.
- The centre has a planned emergency action plan which all staff are aware of and is rehearsed at regular intervals.

#### **Terrorism Attack**

In line with Martyn's Law (Terrorism (Protection of Premises) Act 2025) UK Youth has assessments and measures in place to do all they can to protect the public should a terrorist incident occur at Avon Tyrrell.


#### **Data Protection**

### **Health and Safety Policy Statement**
