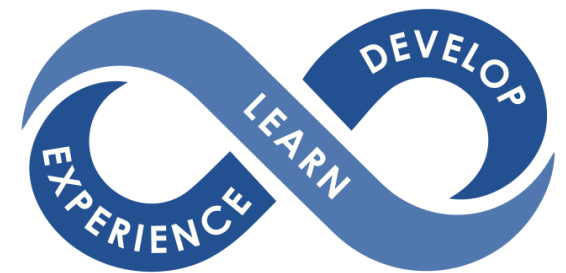

1. What is the deadline for the application?

Tuesday 3rd December at 11:00

2. Is there an upper and lower age limit?

Yes, the funding is only for 11-18 years, or up to 25 years for those with SEND.

3. What does the funding cover?

Day visit Essential Criteria:

- A minimum of 5 hours delivery time with lunch provided.

Residential Essential Criteria:

- A minimum of 12 hours delivery time and 2 nights full board accommodation with hot cooked meals.

4. Can I select more than one date?

Yes, please select as many dates as you are able to attend across both residential and day visit options. You will not be allocated any dates that have not been selected, so the more dates you can do, the better opportunity you will have for securing spaces.

5. Is the programme flexible?

Whilst there are set criteria for the programmes in terms of hours of delivery, we can create a bespoke programme for your group to support additional needs, activity choices and arrival and departure times.

6. How long does the day trip have to be?

We can tailor the activity days around your arrival and departure times, however please note that we do need to ensure your group has 5 hours of delivery as part of the programme.

7. Is there a limit on the number of leaders we can bring?

Generally no, however leaders are not included in participation numbers. If they are looking to extend leader numbers beyond the recommended 1:10 (or 2:10 if bringing a small group), please let us know in the information form so we can allocate the appropriate accommodation space for your group. You may then need to apply for discretionary funding to support additional leader spaces

8. The funding is targeted at disadvantaged young people, what definition of disadvantage are you using to define who is eligible?

As part of the funding application form you will be asked to outline the groups of young people that you plan to target with this funding. This includes young people who are; affected by Mental health, BESD (Behavioural, Emotional and Social Difficulties), Black, Asian or Minority Ethnic Communities, Currently, or at risk of being NEET, Disabled Young People, Young people with experience of the Care System or experiencing or at risk of Criminal Justice System, have SEND (Special educational needs and disabilities), Homeless Young People, LGBTQI+, Low-Income Families, Refugee or Asylum Seekers, Rural Isolation, Traveller Community, Young Carers and Young Parents

Whilst this list is quite comprehensive we accept there are other groups of young people experiencing disadvantage so we have included other as an alternative option and would simply ask that you provide a compelling case as part of your application narrative.

9. Can I apply for individual spaces?

No, unfortunately, these visits are only available for organised groups working with young people.

10. When will the visits take place?

Delivery must be complete by the 31st March 2025. We cannot allocate any dates beyond this.

11. When will I receive notification on the outcome of my application?

All successful applicants who have submitted their application prior to 11 am on the 3rd December 2024 will receive confirmation on whether their application has been successful and dates allocated, no later than Monday 9th December 2024.

12. What reporting requirements will there be?

We want the reporting requirements to be proportional to the size of the grant. Therefore, we will be asking for you to complete a short online reporting form which will be provided to all successful applicants and must be completed within 7 days of your delivery end date.

We will want to know about the impact the programme has had on the young people who accessed this funding.

We also want to maximise the opportunity to spotlight and showcase the work of outdoor learning provision and will ask each organisation to submit 5 photos of their delivery in action. We will also be looking for case studies and organisations who are willing to create digital content we can use to demonstrate the impact of youth work.

13. Do I have to be part of the UK Youth Movement to apply?

No, but we encourage all applicants to sign up to the UK Youth Movement newsletter to become part of a network that shares opportunities for young people and the youth sector, gaining free access to events, campaigns, training, peer support, themed networks and programmes. We'll keep you up to date on all of these opportunities through our optional fortnightly newsletter.
